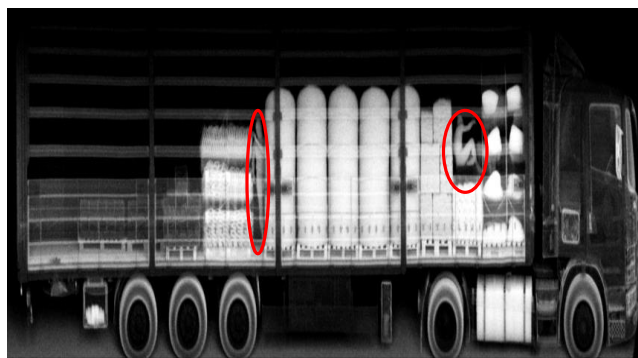

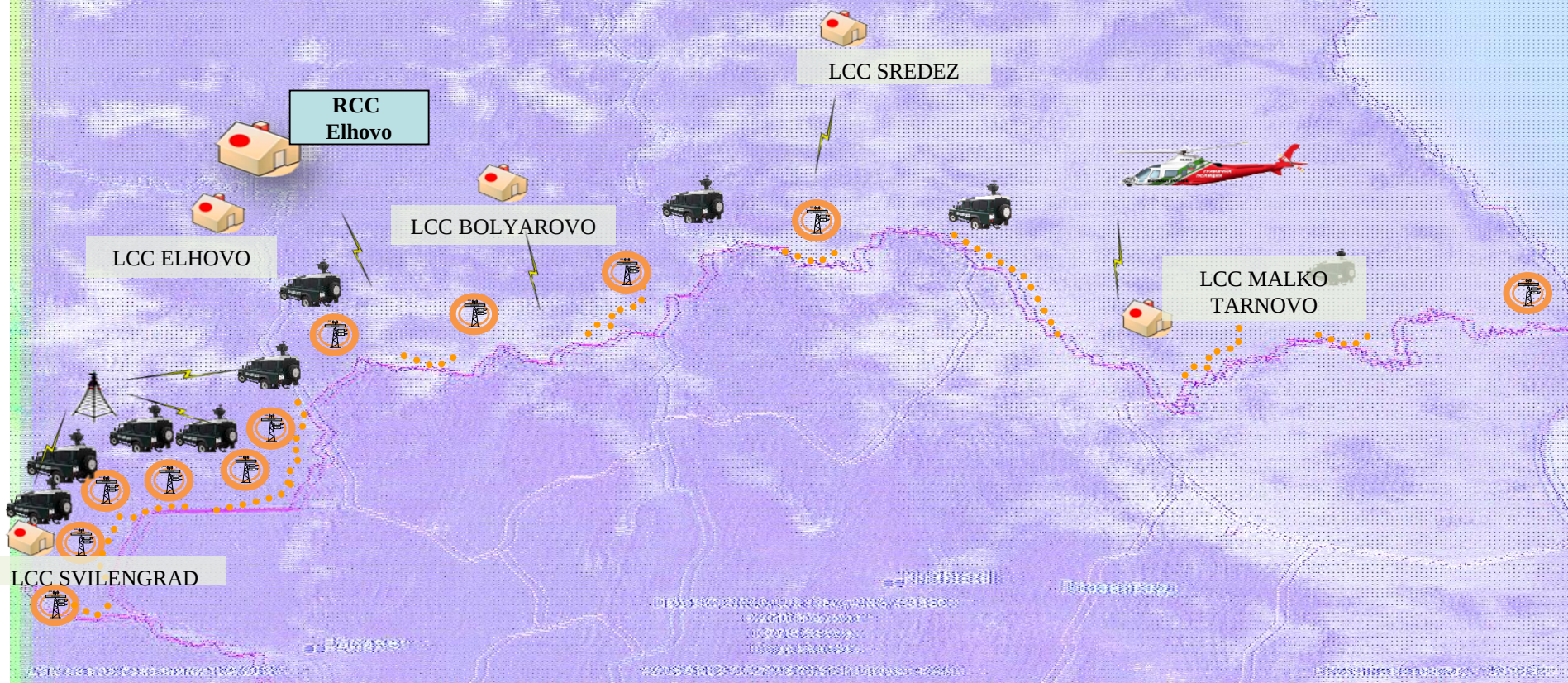

INTEGRATED BORDER SURVEILLANCE SYSTEM ALONG THE BULGARIAN-TURKISH BORDER



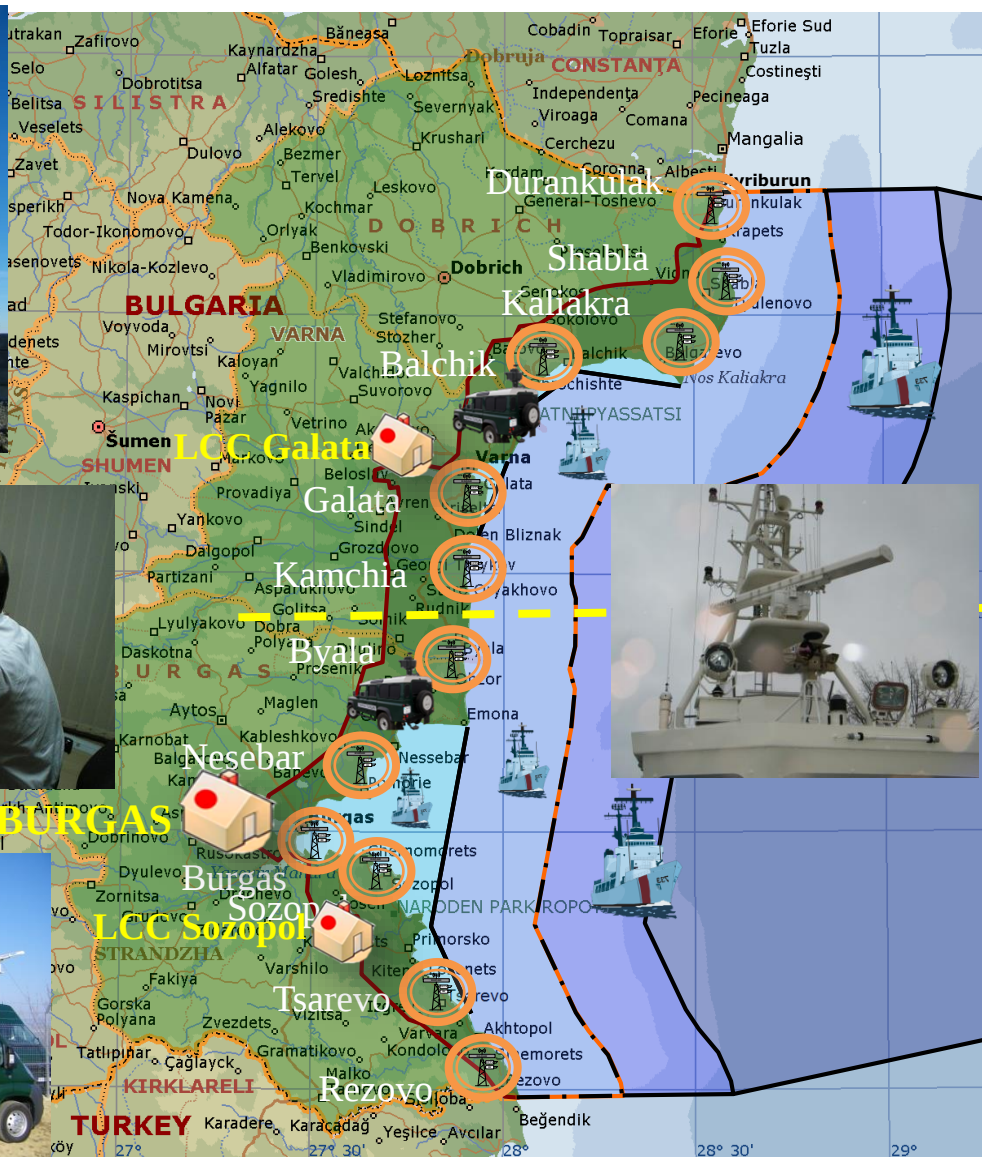


INTEGRATED BORDER SURVEILLANCE SYSTEM “BLUE BORDER”

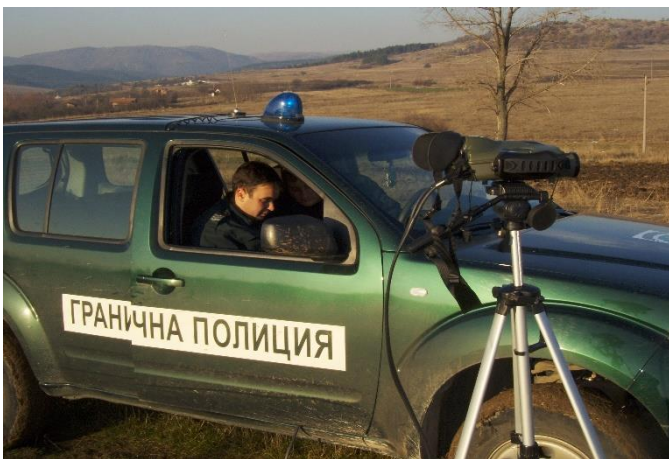

MEASURES FOR MIGRATORY INFLUX COUNTERACTING



- Action plan for increased migratory influx emergency situation along the Bulgarian - Turkish state border, passed at the closed meeting of the Council of Ministers, on 20.07.2016.
- Plan of the General Directorate Border Police for actions during increased migratory influx emergency situation at the Bulgarian - Turkish state border or the Black Sea, approved by the director of Border Police.
- Involvement of armed forces for state border protection;
- Building of temporary engineering technical obstacle equipment at the Bulgarian-Turkish border;
- Carrying out rescue police operations along the Bulgarian – Turkish border and in the adjacent border zone of the Republic of Greece (in the responsibility zone of Novo selo);
- Legislation changes;
- Supply of new motor vehicles;
- Bilateral and multilateral cooperation;
- Cooperation and interaction with Frontex;
- Implementation of Integrated Border Management surveillance systems for both the maritime border and the Bulgarian-Turkish border.

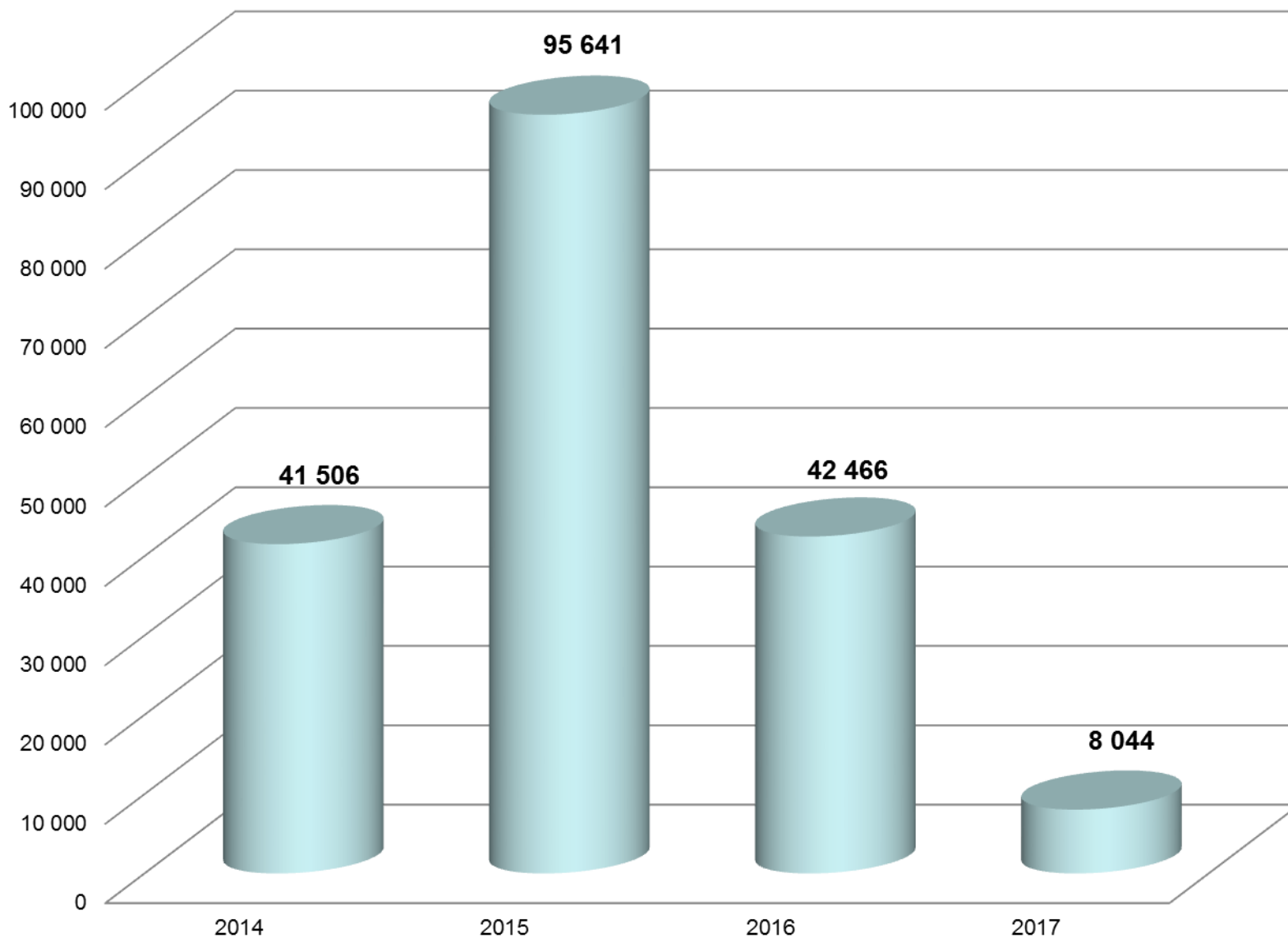

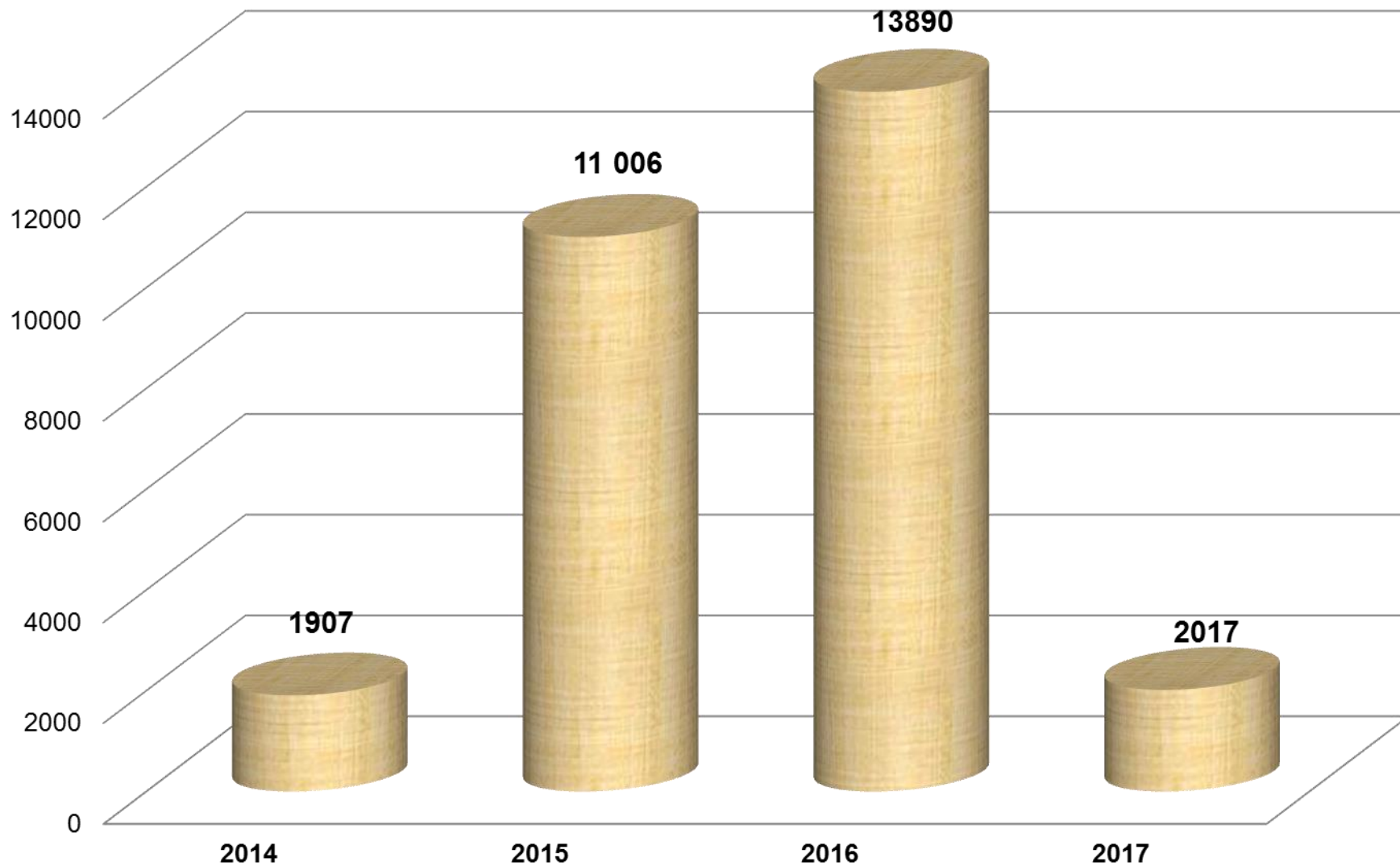


MIGRATORY PRESSURE ON ENTRY

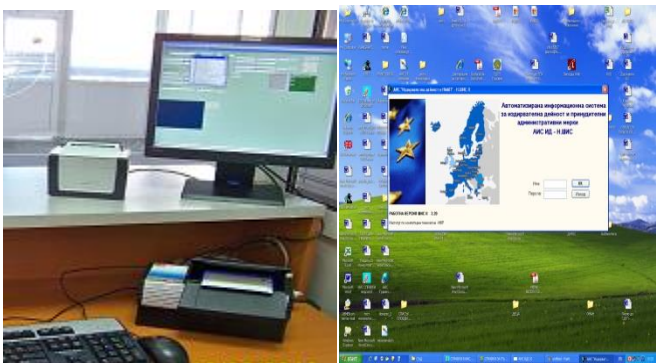

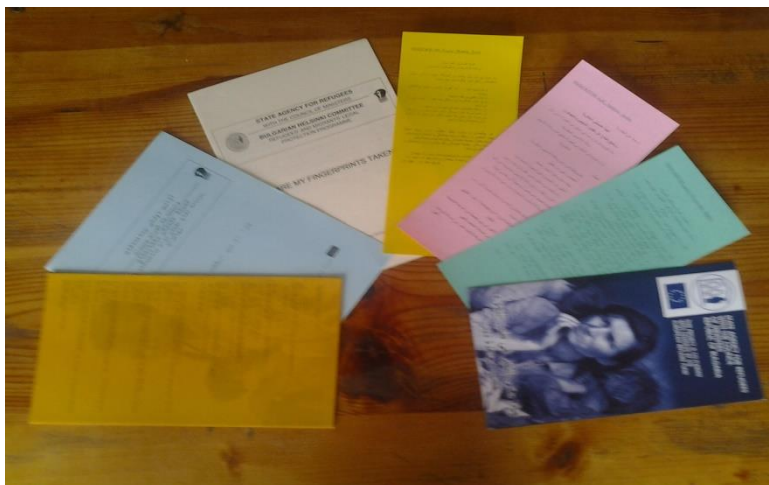
