1. BACKGROUND INFORMATION

As a result of the administrative-territorial reform in Latvia, the network of cultural institutions will be optimized, also creating new synergies both between cultural institutions and with other sectoral institutions, such as libraries becoming involved in ensuring access to state and municipal services in the regions.

The Ministry of Culture of the Republic of Latvia as Delegated Authority of Asylum, Migration and Integration Fund is planning to organize an open call within activity “Activities that provide innovative approaches to promote integration process”. Taking into account the existing experience of libraries implementing projects for inclusive society, the Ministry of Culture would like to gather experience from other Member States to identify the range of activities libraries implement in the field of integration and social inclusion for third - country nationals implementing projects within the Asylum, Migration and Integration Fund. Information provided would assist in elaboration of conditions for project call in order to get the best results and make sure that the new submitted projects will create new forms of cooperation and promote building an inclusive society.

Ministry of Culture of the Republic of Latvia is responsible for implementation of activity "Cohesion of society by promoting skills of self-organisation and improving opportunities for cooperation and participation" under structural funds of EU.

According to data, society - civic participation is weak and social dialogue and civic participation is low thus by implementing activity, we would like to strengthen overall knowledge of democracy in the society of Latvia and therefore improve mutual cooperation and participation of third - country nationals at local and regional level. We believe that thus we will enhance cohesion of society and inclusion of disadvantaged groups.

Support is planned for the development and empowerment of self-organisation, cooperation and participation skills, especially for low-income groups, non-citizens and Russian-speakers, ethnic minorities, the Roma community and the diaspora. Public participation activities are planned to promote the development of a cohesive and civically active society,

These Centres also have as mission to encourage social, economic and political participation of third-country nationals in intercultural exchanges, and to promote civic participation and democracy. This document (in French) details the activities that can be carried out as part of the call for projects of the Walloon Region (http://actionsociale.wallonie.be/sites/default/files/AAP%20ILI%202022-20...).</p> <p>In the Flemish Community: in addition to the pillars of social orientation, learning Dutch and a pathway to work, the civic integration programme is extended by a 4th pillar in 2023, namely a participation and networking trajectory. With this participation and networking trajectory, the persons integrating follow an additional tailor-made programme to strengthen their social network and participation. Some examples are a buddy project, an introductory internship at a company, association, organisation or local government or volunteer work. The participation and networking programme lasts a minimum of 40 hours. The person integrating can combine various activities. The activities take place in a Dutch-speaking context and must promote social participation. Several regional or local level NGO's offer the opportunity for buddy projects or volunteer work. There is for example the Federation for Global and Democratic Organisations (https://www.fmdo.be/fmdo) which supports member associations, works through projects to make a positive impact in the super-diverse society and coordinates buddy projects.</p>

The role of libraries is recognizing by the Government Office for Human Rights and Rights of National Minorities which is preparing a project co-funded by AMIF. As part of this project, one of the activities focuses on libraries</p>

			<p>within the local community. This particular activity aims to implement local initiatives for the social inclusion of third-country nationals in libraries located in four cities. Financial resources for these local initiatives will be allocated based on the developed proposals, and they will be executed through contracts in the four libraries within these cities. The goals of these local initiatives encompass increasing public awareness about the challenges of integrating third-country nationals. This will include a special emphasis on individuals granted international and temporary protection, and an effort to familiarize them with cultural and traditional similarities and differences when compared to the most common categories of third-country nationals in the community. Furthermore, the initiatives seek to strengthen social interaction between the local community and third-country nationals.</p> <p>Below, you can find one example of a good practice:</p> <p>2) After few Syrian families were resettled to city of Karlovac, the Ivan Goran Kovačić City Library in Karlovac very soon became one of the stakeholders that helped them integrate into the Croatian society faster and more easily. Social mentors brought the Syrian families and the City Library staff together. In the first months, the staff worked with the new beneficiaries informally, mostly in the form of organising occasional Croatian language courses for young people on the Library premises. Aiming to organise systematic activities and learn more about working with refugees, the Ivan Goran Kovačić City Library in Karlovac applied for Erasmus+ with the project “Unlocking Library Potentials Through Inclusion”. The project was co-financed by the EU under Erasmus+, Key Action KA104 (adult learning). The key objectives of the project included developing the library staff’s competences through mobility in European countries, and learning new skills and gaining new experience to aid in working with disadvantaged social groups. The skills and knowledge thus gained were going to be used to improve the quality of the existing services for vulnerable groups, but also to develop new services and programmes for asylees and migrants. Among the three mobility activities that they applied with and that were financed under Erasmus+, the first dealt exclusively with working with migrants. The first activity took place at the City Library in Ljubljana, Slovenia on</p>

			<p>4-10 October 2020. Participants acquired new knowledge and skills to reinforce the Library's existing services that include working with asylees and other vulnerable groups, and develop new ones. When the mobility activity was concluded, the implementation of the newly acquired skills started in the Library's work with asylees. The objective of this project was to position the library as a recognisable centre for working with vulnerable groups of adult beneficiaries in order to integrate them into the social and economic life. The programme included carefully designed creative and educational programmes and activities, including innovation in working with migrants:</p> <ol style="list-style-type: none"> 1. Croatian language learning. Additional learning assistance is provided to beneficiaries who come across minor or major difficulties in learning the Croatian language and culture. 2. Programmes promoting entrepreneurship and financial literacy. The Business Library of the Ivan Goran Kovačić City Library in Karlovac is the first library of this kind in Croatia. So far, the Business Library's services were focused on promoting entrepreneurship and financial literacy among young people. Now the Library has expanded its services to other vulnerable groups as well (with a particular focus on migrants, applicants for asylum, and women in a disadvantaged position). Migrants contribute to the economic growth of their recipient countries in a number of ways, introducing new skills and competences, and helping alleviate workforce shortages. In addition, raising awareness of the positive role migrants can play as entrepreneurs contributes to a balanced perception of immigration in the public. 3. Digital/ICT literacy. The training was designed to give the attendants the basic knowledge of ICT skills. Attendants were taught how to use computers for basic purposes such as writing personal/business correspondence, searching for information online (laws, human rights, job opportunities etc), sending e-mails, preparing presentations, managing their finances, etc. 4. Individual support. Individual support ensures the inclusion of beneficiaries in the

			<p>community, helps them find jobs or study programmes to enrol into, provides access to all library services, and presents lifelong learning opportunities provided by the library.</p> <p>5. Cultural competence sharing. Experiences, customs and values from their country of origin are shared with the new group of beneficiaries in order to overcome existing stereotypes, promote tolerance and interculturalism, and contribute to social integration.</p> <p>The implementation of programmes and activities for the families from Syria started in July 2021. Before organising the trainings for adult beneficiaries, an initial survey was carried out to find out about their needs and areas of interest, and a learning plan was drawn up based on this information. Even though the library is an informal education institution, in preparing the Croatian language courses for asylees, the Library follows the Decision of the Ministry of Education and Science on the Croatian language, history and language learning programme for asylees and foreigners under subsidiary protection for purposes of inclusion into the Croatian society, taking into account the recipients' previous learning, and adapting the programme to their conditions, needs etc.</p> <p>During the summer, the programme was organised every Saturday morning at the Youth Library. Children came to the Youth Library together with their parents, where volunteers from the Karlovac Grammar School helped them with their school tasks (homework, repetition, learning for exams...). Taking into account the wishes and interests expressed by programme participants, two educational tourist tours of the old Karlovac city centre were organised during the summer in cooperation with licensed tourist guides. The tours were an excellent way to teach the families from Syria about the cultural, historic and tourist heritage of Karlovac.</p> <p>Having seen stories about the Library in local media and on local TV, librarians from the Library of the Zagreb Faculty of Philosophy started a campaign to collect and donate Croatian language learning books and books to add to the collection of the Central Library of Slovenians in Croatia to the Ivan Goran Kovačić City Library. 			<p>language learners were granted the access to and use of the donated books at the Library. In June 2022, the Dialogue Culture Centre, in cooperation with the Ivan Goran Kovačić City Library, prepared a presentation of Syrian customs, culture, food, and in particular the children's successes, titled "Dialogue with the Orient – Getting to Know Syria", under the project "New Neighbours". The Syrian families living in Karlovac today are an example of good integration of refugees, having been accepted wonderfully by the locals. The event was designed as a meeting place for the new arrivals from Syria and the locals from Karlovac. Little Syrians showed how well they learned the Croatian language, presented their taekwondo skills, and demonstrated the progress they have made in learning to play musical instruments. This all goes to show that, in addition to attending regular education, they like to participate in sports and fun activities, and have made the first step in their assimilation into the Croatian society by themselves.</p> <p>3. In the framework of its implementation, libraries have been involved in several cases. These were usually NGO projects aimed at supporting libraries in opening up to immigrants and training library staff in basic counselling. A project for tutoring children after school on the library premises has long been considered as very good. The involvement is mixed - both children from the majority society and immigrants are tutored, and you can find immigrants among tutors. For example, as of spring 2022, libraries have assisted Ukrainian war refugees (and other newly arrived migrants) in using digital tools, including how to register for the adaption programme (which can also be done in an online environment). Libraries offer computer access to different government services, such as adaption programme's online training. Libraries act as important cultural centres at local level, for example by hosting integration events, language cafes and other language learning activities. Same activities are planned for the future as well, including in the framework of projects funded by the European Social Fund during the new funding period.</p> <p>3. No</p> <p>4. Comment: Until now, libraries have not taken part in AMIF-funded calls for proposal. However, the Ministry of Culture has supported a nationwide project called "All Estonia Reads!" (in Estonian: Kogu Eesti loeb!) - libraries organized events to bring together people with different mother languages on National Minorities Day in several regions across Estonia. Comment: Regarding plans for the future, within the framework of Estonian-Switzerland cooperation programme, the Ministry of Culture will sign a partnership agreement with the National Library of Estonia (Rahvusraamatukogu) to provide free digital and media literacy training to Estonian residents aged 50+ (mainly low-income, newly arrived migrants and non-native speakers). The aim of the project is to increase the coherence and cohesion of Estonian society by promoting access to modern objective information, unbiased media and secure digital services.</p>

One of the topics in the civic orientation training textbooks is Politics and Civic participation in Finland which strengthens the knowledge of democracy of Finnish society among migrants.</p> <p>Materials: https://pakolaisapu.fi/materiaalit/ (Page is in Finnish but materials can be found in English and other languages under “Yhteiskuntaorientaatio”).</p> <p>Projects funded by ministries but NGOs and other actors actively involved in the projects: Another actor is the Advisory Board for Ethnic Relations (Etno) which is coordinated by the Ministry of Justice. Etno aims at enhancing dialogue and cooperation among immigrants, ethnic, cultural and religious minorities, the authorities, political parties and NGOs by organizing regular meetings and discussion events with different actors. In addition, one of their functions is to enhance the democratic knowledge and societal activities of the ethnic minorities. Even though Etno is coordinated by the government, its advisory board consists of different actors from different levels in society. Citizens, through numerous media and resources, receive an abundance of information; but, in this context, it is necessary to have the necessary ability to transform information into knowledge, and this ability is achieved thanks to the reading habit. Only in this way can citizens aspire to participate in and enjoy equally the possibilities offered by the "knowledge society": reading is choosing perspectives from which to situate our gaze, inviting us to reflect, to think and to create."</p> <p>On the other hand, the Action Plan for the Promotion of Reading (2021-2024) of the Ministry of Culture and Sports, recognized that "Reading is a determining factor not only for the individual growth of each person, but also as an essential element for the construction of a better society.
